#### SPONSORSHIP GROUP

# ICA does not sponsor with individuals alone. Kindly note that ICA will not help you find other sponsors to join your group.

All members of the sponsorship groups must reside in the Greater Victoria area. To sponsor a single refugee, you must have a group of at minimum five persons. For larger case compositions, more persons are required. We require you to have a group who is willing to take on the legal responsibilities of the sponsorship with you.

#### **FUNDRAISING**

Sponsorship groups must fundraise a sufficient amount of funds to support the sponsored refugees during their first year in Canada. Approximately to sponsor a single person, the sponsorship cost is a minimum of \$25,000. Approximately to sponsor a family of 5 (father, mother, three under-age children), the minimum sponsorship cost is approximately \$55,000. If there are more adults (persons 18 years or older at time of arrival in Canada) in the family you wish to sponsor, the sponsorship costs will be higher. The exact costs vary based on factors that will need to be discussed in more detail, but please use these figures as approximations. ICA requires that a minimum amount equivalent to the Resettlement Assistance Program rates issued by the Government of Canada (<a href="http://www.rstp.ca/en/bvor/rap-resettlement-assistance-program-rates/">http://www.rstp.ca/en/bvor/rap-resettlement-assistance-program-rates/</a>), plus inflationary market adjustment of 25%, be deposited with ICA before an application can be submitted.
